The formal discussion was suspended, and the committee then engaged in a two-on-two discussion. The Delegates of Germany and the Netherlands spoke first on the pro-side, followed by the Delegates of Thailand and China on the conside. Member nations made their opening remarks before the discussion on the agenda's legalisation of prostitution began. Transwomen are not women, the delegate of France said, to which the delegate from Germany disputed and stressed and replied to how there's no difference between the two. The Delegate of France then brought up the unethical nature of prostitution and sexual activity, to which the entire committee objected. A few other delegates also proved the country wrong.







The delegate of Thailand questioned whether you would sell yourself to your own father if he paid for everything you needed to survive, including food and shelter. The delegate of United Kingdom also inquired as to whether the daughter engages in sexual activity with her father and argued that, even if she does, there would be no reason for her to become a prostitute for her dad. The delegate Austra added that having sex is only permitted after marriage. The German delegate objected, arguing that having sex is something you may do both before and after marriage and that there is no requirement that you do so.

The first session began with a roll call of all the delegates, all of whom appeared eager to win. Iran's representative raised the first motion and began the opening remarks, with the representative of the Russian Federation serving as a witness. Regarding Russia's progress, the US imposed sanctions. Iran has maintained diplomatic ties with Australia as well as a close partnership with China. The delegation went on to state that Iran had further backed Lebanon in the 2006 conflict.

While the US is consistently preoccupied with its own agenda. The Russian federation discussed seizing assets and billions of dollars that were held as part of the US arrangement. Additionally it has violated the treaties directly of the right of freedom and navigation and commerce.

The United States presented it's case by stating it's immensely impressive foreign policies and alligated Iran of producing enriched uranium followed by Germany and France supporting the US by stating the killings done by the Iranians and the violated human rights.

After many failed mods, the delegates decided to move into a moderated caucus raised by Germany on Nuclear weapons. In which, US stated Iran as a "rogue" country and Japan throwing shade on Iran's deeds to disturb world peace.

After the delegates returned to the committee for the second session, the blocs rejected 4-5 motions in a row before passing an Unmod for 10 minutes. The delegates ultimately supported a mod caucus on humanitarian rights where the Russian Federation delegate underlined the effects of the US sanctions on the Iranians' ability to access basic necessities. The US and it's allies stated the wrong doings done by Iran against it's own citizens to which Iran had nothing to say in defence. After which Russia, Germany, Morocco and Slovakia got into a heated argument.

Over all it was a great session for the first day and all the delegates tried their best to make the session interactive and productive.

USA was against the motion and that taking the life of someone justifiable, let alone, blaming it on ancestral practices. Uganda somewhat agreed with this stance by

acknowledging cannibalism as traditional African healing practice and that if the countrymen readily buried this gruesome tradition then Netherlands could do the same.The delegate of India proposed the motion

of necessity being a justiciable reason. Open debate commenced between the delegates with the approval of the chair, Uganda against cannibalism, argued with Germany on the absence of laws against cannibalism in their country and how they are not ready for laws but for convictions, with that, the committee session came

to an end, The sessions had thought-provoking discussions and arguments that were put forth by the delegates. The chair was wise in their words and made the HSC committee an exciting and fruitful one.

This ends the committee here it was a very fruitful session today!






